**APPLICATION FOR HIGH SCHOOL ONLINE COURSE**

Electronic and online learning is increasing in prominence, not only in education but within the workplace, nationally and globally. Conestoga’s online coursework pilot program is designed to provide students the opportunity to earn up to one (1.0) elective credit for coursework completed online. The program is funded by the District. Courses are delivered primarily through the Internet and may involve the use of streaming audio/video, threaded discussions and postings, and web-based communications. Students may use available computers and resources in the library to complete coursework or may participate in the class outside of the school day. Online courses will be granted the same credit value as face-to-face courses, in most cases half-credit (.5) for a semester course and full-credit (1.0) for a yearlong course.

Refer to the Student Services webpage for a current listing of pre-approved online courses. Additional courses may be considered at the request of the student, but will require a full review by the assigned curriculum supervisor. Space may be limited on a first-come, first-served basis.
