After reading the proposed Resolution on District Equity Statement, the NAACP Main Line Branch fully supports this resolution as expressing an understanding as to what is needed to begin the process of providing a remedy to systemic racism.

The branch supports this statement for the following reasons:


1. There is a huge difference between equity and equality. Equality means that everyone gets the same thing. For this to be satisfactory, the assumption is that everyone has the same needs, the same experiences, the same advantages and is beginning at the same place.

- 2. However, equity responds to the difference in needs based on systemic barriers for which someone is trying to overcome. The barriers could be disabilities, imposed assumptions because of race, a lack of understanding of cultural differences from professional staff and just out right racism.
- 3. The approach included in the Resolution regarding anti-racism is consistent with liberation and social justice efforts which seek to completely remove the existing structural barriers.

To acknowledge in this Resolution that "it is the role and responsibility of the entire Tredyffrin/Easttown School District, at every level, to dismantle and abolish any structure or system that unjustly discriminates against fellow members of our community" is where the district must start.

Please know that the NAACP Main Line Branch looks forward to partnering with you as you pursue your goals in eliminating racial barriers from the equation of providing an equitable learning experience.
