Committee Discussion and Recommendations:

Discussion:

The Ad Hoc School Region Reapportionment Committee met on January 26 to discuss two District reapportionment plans and two community member submitted reapportionment plans, hereafter known as Plan A, Plan B, Plan X and Plan Y. All four plans meet the parameters required by the state, the consensus criteria established by the Committee as well as many of the other criteria established by the Committee at its first meeting. The Committee examined each of the four plans to assess which best met the criteria for consideration. District Plan A was eliminated as not meeting the criteria of being sustainable for some time, leaving Plans B, X & Y open for consideration. These three plans were evaluated against each of the "other" criteria using the 2010 Census, Broke Ground developments and Approved Developments. Each Board member and Community member present voted on which plan best met each criterion. The results are summarized in the chart below.
