# **Priority Discussion**

# Valley Forge Middle School Fencing Project

Business Manager Art McDonnell and architect Thomas Daley presented an overview of past District fencing projects and a schematic representation of the VFMS fencing recommendations detailed in the written report of the Safety and Security Consultant.

The Board of School Directors approved the installation of a fence at VFMS consistent with the recommendations in the school safety and security consultant's January 6, 2016 report. The Board retained Daley + Jalboot Architects, LLP to develop construction documents, administer the bid process, and oversee the installation of Site Fencing at VFMS for a fee not to exceed \$6,800 per the March 23, 2016 proposal letter.

# **One:One Computing Initiative**

Director of Instructional Technology Michael Szymendera and Business Manager Art McDonnell presented an overview of the One:One Computing Initiative.

The Board of School Directors approved a lease between the Tredyffrin/Easttown School District and Dell Financial Services, LLC for computers for use in the District's One:One Computing Initiative in accordance with the terms and conditions set forth in the Master Lease Agreement and other Master Lease documents in an amount not to exceed \$550,000. The
