Crossing Guard Agreement

The Board of School Directors approved an agreement with Tredyffrin Township to resolve any and all alleged outstanding obligations of both parties under the July 11, 2007 letter of understanding with respect to crossing guards through the date of execution of the Agreement, and simultaneously rescind the provisions of such letter of understanding relating to crossing guards as of the date of the Agreement.

The Board further requests Tredyffrin Township to pass an ordinance authorizing the District to assume the hiring and oversight of school crossing guards pursuant to 53 P.S. 66915.
