Priority Discussion

Adoption of the 2016-2017 Final Budget The Board of School Directors approved the 2016-2017 Final Budget submitted by the District's administration.

The Board approved the final 2016-2017 budget in the amount of \$128,503,741 revenues, \$2,766,651 fund balance allocation, and \$131,270,392 for expenditures, with a tax rate of 21.7423 mills. This is an increase of .7555 mills from the 2015-2016 tax rate. This tax rate increase translates into an annual increase of \$191 on the average T/E home.

Agreement with ComedySportz Philadelphia

The Board approved the agreement between the T/E School District and ComedySportz Philadelphia to lead four workshop sessions on November 8, 2016 at a cost of \$3,300 plus travel expenses. The sessions will focus on the Artistry of Teaching and collaboration and communication strategies for the professional staff.

Agreement with Dr. Arthur Benjamin

The Board approved the agreement between the T/E School District and Dr. Arthur Benjamin to lead two workshop sessions on November 8, 2016 at a cost of \$4,000 plus travel expenses. The sessions will focus on the Artistry of Teaching and specifically techniques for making math instruction exciting and engaging for the professional staff.

Request for Proposal-Traffic Study

The Board awarded a contract to Traffic Planning and Design, Inc for a District-Wide Traffic Study.

Tax Bill Homestead/Farmstead Exclusion

The Board adopted a resolution which pertains to the approval of the Tax Bill Homestead/Farmstead Exclusion for the 2016-2017 fiscal year. All approved homesteads and/or farmsteads shall receive a homestead/farmstead exclusion that corresponds to a tax reduction of 182.61.

Appointment of Insurance Broker of Record for the 2016-2017 School Year

The Board appointed the firm of Willis Towers Watson to serve as the Insurance Broker of Record for the year July 1, 2016 through June 30, 2017.

Appointment of Depositories for the 2016-2017 School Year

The Board approved National Penn Bank and BB & T Bank to serve as depositories for the Tredyffrin/ Easttown School District for the year July 1, 2016 through June 30, 2017.

Agreement with Forecast 5 Analytics, Inc.

The Board approved the agreement between Forecast 5 Analytics, Inc. and the Tredyffrin/Easttown School District for advisor fee, and license for the 2016-2017 not to exceed \$13,960.

Upper Main Line YMCA Rental Contract

The Board approved the rental contract between the Tredyffrin/Easttown School District and the Upper Main Line YMCA for the use of its tennis courts for the high school tennis team.
