**Approval of Transfer to Capital Reserve Fund**

**Crossing Guard Agreement**

The Board of School Directors approved an agreement with Easttown Township to resolve any outstanding obligations of both parties under the July 11, 2007 letter of understanding with respect to crossing guards.

The Board further requested Easttown Township to pass an ordinance authorizing the District to assume

the hiring and oversight of school crossing guards pursuant to 53 P.S. 66915.

### Upper Main Line YMCA Rental Contract

The Board of School Directors approved a contract between Conestoga High School and Upper Main Line YMCA for the use of its pool for the high school swim team for a total of \$13,165.

##### 2018-2019 Instructional Calendar Memorandum of Understanding and Resolution

The Board of School Directors approved the Memorandum of Understanding (MOU) between the Tredyffrin/Easttown School District and the Tredyffrin/Easttown Education Association. This MOU designates August 22, 2018 as the earliest first day for returning teachers for the 2018-2019 school year.

The Board of School Directors adopted a resolution which sets the instructional calendar for the 2018-2019 school year and designates Section 1502 and Act 80 days as part of the approved calendar.

#### Revised Policy 6146: Student Athletics, First Reading

The Board of School Directors approved the Revised

Policy 6146: Student Athletics, on a first reading basis, as ready for adoption at the next regular meeting.

#### November Election Ballot Question
