A Recap of the January 2, 2018 Regular School Board Meeting

**At the January 2 Regular Board Meeting, the Board approved the following.**

### **Priority Discussion**

#### **2018—2019 Preliminary Budget Proposal**

The Board of School Directors authorized the Administration to make the 2018—2019 Preliminary Budget Proposal available for inspection not later than January 3, 2018;

Authorized the Administration to provide public notice not later than January 12, 2018, that the Board intends to adopt a Preliminary Budget at its regularly scheduled meeting on January 22, 2018;

Authorized the Administration to take any and all actions necessary to ensure legal compliance with approval of the Preliminary Budget;

Authorized the Administration to publish notice of the intent to file for referendum exceptions with the Pennsylvania Department of Education and/or the Chester County Court of Common Pleas at least one week prior to filing for such exceptions and to file for such exceptions not later than March 1, 2018;

Adopted this 2nd day of January, 2018.

#### **Reappointment of Superintendent**

The Board of School Directors, pursuant to Section 1073 of the Public School Code, recommended the reappointment of Dr. Richard Gusick as District Superintendent for a term to commence July 1, 2018 and to end June 30, 2023. It is further recommended that the Board of School Directors approve the Employment Contract between the District and Dr. Gusick.
