Athletic Position Stipends for Fall of the 2016-2017 School Year

The Board of School Directors confirmed the administrative stipends for the athletic positions for the fall season of the 2016-2017 school year.

Additional 2016 Summer Workshops and Participants

The Board of School Directors approved workshops and participants at a rate of \$40 per hour in accordance with School Board Policy #4505 and the negotiated agreement.

Agreement with KA Productions

The Board of School Directors approved an agreement between the Tredyffrin/Easttown School District and KA Productions to lead two workshop sessions on October 10, 2016 at a cost of \$3,166.

Agreement with Blackboard

The Board of School Directors approved a two-year agreement with Blackboard and the Tredyffrin/Easttown School District for web hosting, support and/or services in an amount not to exceed \$13,127.40.
