Public Comment:

Approval of Minutes:

The March 23, 2017 minutes were approved.

Committee Discussion and Recommendations:

The Committee discussed the **Proposed Property Tax Elimination Bill.** Dr. Wendy Towle shared with the Committee that there is no new information about this plan at the present time. There were no Committee recommendations.

Dr. Towle shared a newly revised piece of legislation, **House Bill 1213**, that deals with the opportunity for Districts to appeal property assessments initiated by local taxing authorities. The Committee discussed the impact this legislation would have on the District. The Committee reviewed a resolution opposing House Bill 1213. The Committee then recommended the resolution be put forward for a vote by the full Board at the May 22 Board meeting. Additionally, the advocacy efforts around House Bill 1213 will be shared with Township officials and other school districts.

Dr. Towle provided an update on **Medicaid/ACCESS Funding**. The Committee discussed the impact the proposed federal legislation would have on the District. Mr. Chris Groppe, Supervisor of Special Education, provided examples of how the funding supports students and provides services to students within the District. Although the District takes no position on Federal Health Care Reform, the concern is the reduction of funds that can provide students with needed services and goods. The Committee discussed opposition to this piece of legislation and recommended continuing to monitor the issue with the option to consider a resolution at the June Board meeting.

The meeting was adjourned at 7:00 p.m.
