Approval of Minutes:

The Committee approved the April 25, 2017 minutes.

Committee Discussion and Recommendations:

The Committee reviewed topics and outcomes of the April 25, 2017 meeting.

The Committee discussed **What Principles Informed the Decision to Redistrict.** Dr. Wendy Towle, Director of Curriculum, Instruction, Staff Development, and Planning, outlined the principles for the committee and community members, including: the implementation of the Elementary Blueprint for Instruction should be equitable and consistent across all five elementary schools; the Elementary Blueprint for Instruction should not be modified as a response to the imbalance in student enrollment; the elementary enrollment for the coming five years does not appear to correct the current building enrollment disparities; redistributing students to schools that have capacity is a cost effective solution and would allow flexibility in responding to future enrollment experience.

The Committee discussed **Which Schools Will be Involved in Redistricting.** Dr. Wendy Towle, Director of Curriculum, Instruction, Staff Development, and Planning, explained that demographic projections for 2017-2018 indicate that Beaumont Elementary School, Devon Elementary School, and Hillside Elementary School all fall outside of the target range for the number of students in Elementary Schools in the District, and therefore should be involved in the redistricting plan. The Committee also discussed the demographic changes in the District, the impact on student enrollment at the Elementary Schools, and the demographer's projections.

The Committee discussed **Criteria to be Considered for Balancing Attendance Areas.** Dr. Wendy Towle, Director of Curriculum, Instruction, Staff Development, and Planning, reviewed the current criteria, including: numbers of students (target range for District Elementary Schools is 450-500 students); minimize disruption (3 schools – Devon, Beaumont, Hillside; option for 4th grade 'homesteading'); transportation routes (time on bus, rostering); contiguous neighborhoods; proximity to attending schools; and reasonably shaped attendance areas. Also, the Committee reaffirmed, without additions, the Considerations for Redistricting committee action and will present this option to the full School Board at the May 22, 2017 meeting.

The Committee discussed **Composition of Redistricting Committee**, including: 2 School Board Members as non-voting participants, 3 administrative staff members, 4 parents, an external facilitator, and consultants (demographer, transportation supervisor, etc.). The committee recommended that the volunteer parent members of the Redistricting Committee meet the following criteria: 2 parents from Devon Elementary, 1 parent from Hillside Elementary, 1 parent from Beaumont Elementary; all volunteer parent members must have a child in grade K, 1, or 2 for the 2017-2018 school year; volunteer parent members will be chosen by lottery; 4 alternate volunteer parent members will also be chosen by lottery (2 from Devon Elementary, 1 from Hillside Elementary, and 1 from Beaumont Elementary). The Committee also recommended that the members of the Redistricting Committee be announced before the first meeting in the fall of 2017.

The Committee reviewed the **Timeline for Redistricting.** The committee determined that no future Ad Hoc Committee meetings are needed until June, 2017.
