Kindergarten Field Trip

Information for Parents Interested in Chaperoning

We love to get as many parents involved in our activities as we can. Many parents do not have the opportunity to volunteer regularly in the classroom, and our field trip can be a great chance to join us for a fun day.

To comply with Child Protective Services Law, parent chaperones are required to obtain and submit clearances to the district. For information and directions on obtaining the necessary clearances, see T/E's volunteer page at http://www.tesd.net/volunteers.

To be eligible to chaperone our field trip to Sugartown Strawberries, all required clearances must be received by the school district by Monday, October 14th, when chaperones will be selected. (If you have previously submitted clearances, they will still be on file.) As chaperone positions are limited to five per class, obtaining clearance does not guarantee that you can join us for the trip. Once obtained, background clearances are valid for five years.
