The current tuition rate is \$74.11 per day, per child.

I declare that the statements made herein are true and correct based upon my personal knowledge. I understand that if this Application is violated, or if any information proves to be false, the District has the right to immediately initiate expulsion proceedings against any child improperly enrolled in the District, pursue civil proceedings for the collection of nonresident tuition and costs, and may refer the matter to the appropriate law enforcement officials for prosecution for unsworn falsification to authorities, theft of services, and/or any other applicable criminal offense.
